#### Dear Parent:

The A. Linwood Holton Governor's School Anatomy & Physiology class will be holding their "Fall 2016" field trip on November 20-22, 2016. First semester block and year-long 11:40-12:30 students are encouraged to attend this educational adventure, not only for the learning experience and the social interaction with their peers, but to fulfill the requirements for dual enrollment. (All other students will attend the spring field trip.) Students will be visiting the **Edward Via College of Osteopathic Medicine**, and the **VA-MD College of Veterinary School**, both in Blacksburg, Virginia. The field trip will begin on <u>Sunday</u>, <u>November 20<sup>th</sup> at 6:00 p.m.</u> at the Southwest Virginia Higher Education Center in Abingdon, Virginia. Students are to go directly to their bus, which will be parked in front of the Southwest Virginia Higher Education Center. The field trip will conclude on Tuesday, November 22<sup>nd</sup> at approximately 3:00 p.m. at the Southwest Virginia Higher Education Center. If you will be picking up your daughter/son at the end of the field trip, please be at the Southwest Virginia Higher Education Center around the appointed time. Our bus drivers will make every effort to adhere to the stated schedule.

The medical staff and faculty at each institution are very excited about the upcoming visit of our Anatomy & Physiology students. Holton Governor's School anatomy students will be included in lectures, labs, and current research while there. Students will also take part in a discussion with admissions counselors and current medical students so they can better understand what life is like preparing for a career in medicine.

In order to make this adventure an enjoyable learning experience for everyone, all students will need to abide by the following:

#### Participation:

- ➤ While it is not a requirement to attend this field trip, important lab requirements (for this course) and scientific explorations will be fulfilled at this time. Students who do not participate in this trip will be required to complete a research project that will be assigned by their instructor in lieu of the information they will have missed.
- All students who register for this field trip will be required, without exception, to participate in <u>ALL</u> activities of the field trip.

#### **Transportation**:

Students will travel by bus.

### Luggage, etc.:

> Students will be allowed one (1) medium sized piece of luggage. This luggage MUST display a nametag.

Students will be allowed to bring one small pillow.

### Hotel Information:

- > Students will be staying overnight at the Courtyard Marriott, Blacksburg, Virginia. In case of emergencies, the telephone number of the hotel is 540-552-5222. Only when necessary will students be allowed to make telephone calls, local or long distance.
- > Students and parents will be responsible for <u>any additional</u> hotel charges.
- ➤ Meals will be provided.
- > Students will be considerate of others during their stay and will abide by the rules set forth within the permission form.

#### Cost:

- > Students will need to send a check in the amount of \$50.00 made out to the <u>Holton Governor's School</u>. To allow sufficient time to secure rooms at the hotel, students must have their check *and* paperwork to the Governor's School by **November 4, 2016** in order to participate in this fieldtrip.
- ➤ (Do <u>NOT</u> send cash, money order, or cashier's check. <u>No exceptions</u>.)
- > Students should bring extra spending money for meals traveling to and from, as well as for incidentals.

#### Forms:

- > There are four forms that need to be completed prior to any A&P student attending this field trip.
- ➤ Below are Mrs. Smith's clarifications for the Edward Via College Osteopathic Medicine's (VCOM) consent form:
  - O Consent Form/Lab Waiver/Photographic Release Form—covers the students while at VCOM. Students will be involved in a gross anatomy lab where they will be exposed to several cadavers. It has been my experience that the lab at VCOM is well-ventilated and causes no allergic problems for students. (The Governor's School will provide non-latex gloves for students who are allergic to latex.) Please be assured that I do prepare the students for their exposure to the cadavers. By the time the students go on this trip they will have studied a cadaver that they have on 4 different CDs in their possession now. I have never had a student have any difficulties with the gross anatomy lab. While at the Medical School some photos will be taken of the students that will be sent as press releases to several newspapers in our region as well as the Medical College's region. VCOM will possibly use some pictures in their newsletter which highlights the school's activities. Our Governor's School will possibly do the same.

# **Permission Form**

The following guidelines must be adhered to while participating in any A. Linwood Holton Governor's School field trip. Violation of these standards may result in immediate return of the student as well as subsequent disciplinary action.

- 1. Any student who drives to the Southwest Virginia Higher Education Center must park his or her vehicle in the parking lot across the culvert (below I-81). Students will not be allowed access to personal vehicles until all school activities are completed.
- 2. No alcohol or other illegal substances are allowed. Any violation will result in immediate dismissal.
- 3. No cigarettes, including e-cigarettes, or any tobacco products are permitted.
- 4. Females are not allowed in the male rooms at any time and males are not allowed in the female rooms at any time.
- 5. Students will be in their rooms by 11:00 p.m., unless otherwise stated.
- 6. Students will participate in all activities as arranged by the Governor's School.
- 7. Students will conduct themselves as young adults at all times and remember their actions are reflective of the home and the Governor's School.



In consideration for receiving permission to participate in any of the field trips during this current school year (herein referred to as ACTIVITY) hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, AND AGREE TO HOLD HARMLESS any and all purposes A. Linwood Holton Governor's School, all participating district county school boards, the A. Linwood Holton Governing Board, and their officers, servants, agents, volunteers, or employees (herein referred to as RELEASEES) FROM ANY AND ALL LIABILITIES, CLAIMS, DEMANDS, OR INJURY, INCLUDING DEATH, that may be sustained by me while participating in such activity, or while on the premises owned or leased by RELEASEES. I acknowledge there may be physically strenuous activities. I know of no medical reason why I should not participate.

I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me as a result of participating in said activity. I agree to indemnity and hold harmless the RELEASEES for any loss, liability, damage or costs, including court costs and attorney's fees, which may occur as a result of my participation in said activity. Please remember the following as you prepare for your trip to VCOM: Students will be expected to maintain proper attire. Part of the program will take place in the anatomy laboratory, therefore open-toed shoes, shorts, low-cut, halter or spaghetti strap tops, miniskirts, sleeveless shirts, are <u>not permitted</u>. Students are advised to not use musical devices, cell phones, and cameras during the program. Photography in the anatomy lab is <u>strictly prohibited</u>.

Additionally, the bodies donated to the cadaver lab are looked upon as a family sacrifice that we honor. Please respect the bodies and only touch what a VCOM student or staff member has permitted you to touch, and only if you are wearing surgical gloves. If you are pregnant, you will need to wear a mask. VCOM maintains an excellent ventilation system, but the fumes can still affect a pregnancy.
